Sub: Recognition Certificate for the school under (Rule/ sub- rule of the State Act/ Rules).

Ref: Application for recognition for renewal of affiliation of DAV MMPS, Garka (Government Model School Prior to 2016), presently running on PPP mode.

With reference to your application dated 23/05/2023 , pertaining to recognition of Class 1 to VIII of DAV Mukhya Matntri Public School, Garka, formerly started as Government Model School, by the education department of the state of Chhattisgarh, I hereby convey the grant of Recognition to DAV MUKHYAMANTRI PUBLIC SCHOOL, GARKA, POST – SINGANPUR, DIST- KONDAGAON, (C.G.) for class I to VIII standard for the period OF 04 years,) from the academic year 2023 to 2027 in compliance to section 18 of Right of Children to Free and Compulsory Education, Act, 2009 (State Act/ Rule).

The above recognition is subject to the following conditions:-

1. The temporary recognition accorded to the school is valid from the academic year 2023 to 2027 and is to be renewed at an interval of every 04 years.
2. The grant of recognition is available initially for classes I to VIII standard.
3. The school shall abide by the provisions of the Right of Children to Free and Compulsory Education Act, 2009 and the (State Education Act/Rules).
4. The school shall admit in pre-school / class I to the extent of 32 % of the strength neach class, children belonging to Weaker Section and Disadvantaged Group in the neighborhood and provide free and compulsory elementary education till its completion.
5. The school shall maintain a separate bank account for the purpose of reimbursement.

6. The school shall not collect any capitation fee and subject the child or his or her parent or guardian to any screening procedure.
7. The school shall not deny admission to any child, -
For lack of age proof if such admission is sought subsequent to the extended period prescribed for admission.
 - a. On the ground of religion, caste or race, place of birth or any of them.
 - b. The school shall ensure that,-
 - c. No child admitted shall be held back in any class or expelled from school till the completion of elementary education in a school.
 - d. No child shall be subjected to physical punishment or mental harassment
 - e. No child is required to pass any board examination till the completion of elementary education.
 - f. Inclusion of students with disabilities/ special need as per provision of the (Rule/ clause of State Act).
 - g. The teachers are recruited with minimum qualifications as laid under (Rule/ clause of the state Act).
 - h. The teachers perform his duties specified under (Rule/ clause of the state Act).
8. The school shall follow the syllabus on the basis of curriculum laid down by appropriate authority.
9. The school shall maintain the standards and norms as specified in the state Act).
10. No unrecognized classes shall run within the premises of the school or outside in the name of school.
11. The school building plan must have been approved by the current rules or G. Os. The school building or other structures and the grounds are used only for the purposes of education and skill development. Construction work within the compound should not be carried out in school working hours and safety measures in all respect are under whole responsibility of the managements.
12. The school is run by a society registered under the (Act under with Society is registered), or a public trust constituted under any law for the time being in force.
13. The school is not run for profit to any individual, group or association of individuals or any other persons.
14. The accounts should be audited and certified by a Chartered Accountant and proper accounts statements should be prepared.

15. The school shall furnish such reports and information as may be required by the competent authority from time to time and shall comply with such instructions of the State Government or the competent authority as may be issued to secure the continued fulfillment of the condition of recognition or the removal of deficiencies in working of the school.
16. Hindi, English and Sanskrit shall be taught as a subject from in standards I to VII in all Schools as notified under (Concerned Act/ rule) from academic session recognition is granted.
17. The school shall abide by the provisions of the Chhattisgarh Act/ Rules).
The certificates of recognition issued by the department shall be subject to the fulfillment of deficiencies if any pointed out by the department at any stage/ time.
18. The management shall rectify the deficiencies pointed out in infrastructure or administration by the authorities.
19. The management shall apply for renewal of recognition three months before the expiry of this order
20. The management shall follow the directions issued by the Government/ Department from time to time keeping in view of the safety and security of the children and the overall administration of the school.
21. The recognition shall be withdrawn if any contravention of the provisions of the Act, Rule or the conditions of recognition are found and proved.
22. The school management shall have to full responsibility if any court cases arises this regard.

Note – This school was started by Education department of Chhattigarh prior to 2016 hence the permission for class I – VIII is permanent by nature until the agreement is cancelled.
